## ORDER GRANTING EXTENSION OF TIME TO FILE STAFF RECOMMENDATION

Issue Date: July 13, 2022 Effective Date: July 13, 2022

On May 18, 2022, Jennifer Dutcher filed an application with the Missouri Public Service Commission requesting that her electric supplier be changed from Evergy Missouri West, Inc. (EMW) to Platte-Clay Electric Cooperative, Inc. (Platte-Clay). The Staff of the Commission (Staff) was directed to produce a recommendation, or request an extension of time, on or before July 12, 2022.

In its answer filed on June 28, 2022, EMW stated it believes it has corrected the outage response issue that underlies Ms. Dutcher's application.

On July 8, 2022, Staff requested an extension of time until August 31, 2022, to file its recommendation. In support of its request, Staff states it has developed additional information it wishes to investigate about outage response times. Staff has issued data requests, which will necessitate additional time to review and perform its analysis in preparation of filing its recommendation.

The Commission finds Staff's request to be reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

- 1. Staff's request for an extension of time to file its recommendation is granted. Staff shall submit its recommendation, or a request for a further extension of time, on or before August 31, 2022.
  - 2. This order shall be effective when issued.
