ORDER DIRECTING JOINT PROPOSED SCHEDULE

Issue Date: November 30, 2022

Effective Date: November 30, 2022

On May 18, 2022,¹ Jennifer Dutcher filed an application requesting that her electric supplier be changed from Every Missouri West, Inc. (EMW) to Platte-Clay Electric Cooperative, Inc. (Platte-Clay). EMW responded on June 28, 2022. The Staff of the Commission (Staff) filed its recommendation that the Commission approve the change of supplier request on October 31. On November 10, EMW requested an evidentiary hearing.

The Commission will not schedule an on-the-record procedural conference; however, the Commission will encourage the parties to meet in-person or virtually to discuss a schedule and any related issues. The Commission will task its Staff with the responsibility of coordinating and filing the joint proposed procedural schedule. The Commission directs the parties to include the following in any proposed procedural schedule:

- Submission of a Joint Stipulation of Facts;

- Submission at least one week in advance of the hearing: a list of issues; order of opening statements, witnesses, and cross-examination; and position statements;
- At least one settlement conference;
- Cut-off dates for service of discovery requests and responses;
- Briefing schedule allowing for ten business days for transcript preparation.

Requests for expedited hearing transcripts shall be made before the procedural schedule is established.

THE COMMISSION ORDERS THAT:

1. No later than December 23, 2022, the parties shall submit a status report or a joint proposed procedural schedule as described in the body of this order.
2. This order shall be effective when issued.
