ORDER EXTENDING DEADLINE FOR STAFF TO FILE A RECOMMENDATION AND SETTING A TIME FOR RESPONSES

On October 24, the Commission directed its Staff (Staff) to file a recommendation about the proposed territorial agreement, legal description, and addendum no later than October 31, 2022, and set a deadline for responses. On October 25, 2022, Staff filed a request that its deadline to file a recommendation in this case be extended to November 23, 2022. Staff states that neither Co-Mo Electric Cooperative and Union Electric Company d/b/a Ameren Missouri objects to extending the due date for Staff's recommendation.

Staff additionally notes that while the Commission is to rule on territorial within 120 days, the parties did not file the information required to issue a report and order until October 19, 2022. Accordingly, good cause exists to extend the time period for the Commission to rule on said application beyond the 120 day deadline.

The Commission will grant Staff's extension to file a recommendation and set a time for any responses.

THE COMMISSION ORDERS THAT:

- 1. Staff shall file a recommendation about the proposed territorial agreement, legal description, and addendum no later than November 23, 2022.
- 2. Any responses to Staff's recommendation, the proposed territorial agreement, legal description, and addendum shall be filed no later than December 2, 2022.
