ORDER CANCELING THE FIRST TWO DAYS OF THE EVIDENTIARY HEARING AND EXTENDING THE TIME FOR OBJECTIONS TO THE NON-UNANIMOUS STIPULATION AND AGREEMENT

On November 9, 2025, Union Electric Company d/b/a Ameren Missouri, Amazon Data Services, Inc., Evergy Metro, Inc., Evergy Missouri West, Inc., Google LLC, Renew Missouri, Missouri Industrial Energy Consumers, and Sierra Club filed their *Corrected Non-Unanimous Global Stipulation and Agreement*. Commission Rule 20 CSR 4240-2.115 allows parties seven days to object to a non-unanimous stipulation and agreement otherwise the Commission may treat it as unanimous. Pursuant to that rule, any objections to this proposed agreement must be made by November 17, 2025.

Ameren Missouri filed an unopposed motion on November 13, 2025, to suspend the start of the evidentiary hearing set for November 17, 2025. The Motion states that Ameren Missouri has reached an agreement in principle with the Staff of the Commission and is still in settlement discussions with the Office of the Public Counsel. The motion asks the Commission to extend the deadline for objections to the *Corrected Non-Unanimous Global Stipulation and Agreement* until November 18, 2025, and delay the start of the evidentiary hearing until November 19, 2025.

Commission Rule 20 CSR 4240-2.205 authorizes the Commission to grant a variance to the seven-day objection deadline contained in Commission Rule 20 CSR 4240-2.115 for good cause. The Commission finds good cause to grant the requested variance because the parties are continuing efforts to resolve this case through settlement, and the request is reasonable. The Commission will also cancel the first two days of the evidentiary hearing.

THE COMMISSION ORDERS THAT:

- 1. The first two days of the evidentiary hearing scheduled for November 17-21, 2025, are canceled. The evidentiary hearing shall start on November 19, 2025, at 9:00 a.m. in room 310 of the Governor Office Building.
- 2. The deadline for objections to the *Corrected Non-Unanimous Global Stipulation and Agreement* is extended to November 18, 2025.
 - 3. This order is effective when issued.
