## ORDER EXTENDING DEADLINE

On December 15, 2020, the Commission Staff (Staff) filed its Recommendation Regarding Summit Natural Gas of Missouri, Inc.'s (SNGMO) 2018-2019 Actual Cost Adjustment Filing (Recommendation). The Commission ordered SNGMO to file a response no later than January 27, 2021. Per SNGMO's request and with no objection from Staff, this deadline was subsequently extended to March 2, 2021. On February 23, 2021, SNGMO filed a Second Motion for Extension. SNGMO states that it and Staff have exchanged additional information and that because of other events, neither SNGMO nor Staff believes that the process will be completed by March 2, 2021. SNGMO requests that the deadline for its response to Staff's recommendation be extended to March 23, 2021, and states Staff does not object. The Commission will grant the request.

#### THE COMMISSION ORDERS THAT:

- 1. SNGMO's Second Motion for Extension is granted.
- 2. No later than March 23, 2021, SNGMO shall file a response to Staff's Recommendation.
