ORDER EXTENDING TIME OF TARIFF SUSPENSION

Issue Date: February 22, 2017

Effective Date: February 22, 2017

On August 15, 2016, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed an application requesting that the Missouri Public Service Commission approve a tariff authorizing a pilot program to install and operate electric vehicle charging stations at locations within Ameren Missouri’s service area.

On October 7, 2016, Ameren Missouri filed a revised tariff under Tariff Tracking No. YE-2017-0052, which the Commission subsequently suspended until March 6, 2017 in order to conduct a hearing regarding the proposed tariff. Due to the necessity of amending the procedural schedule in this case, the final briefs will not be submitted until February 28, 2017. There is insufficient time for the Commission to deliberate and issue a report and order before the tariff becomes effective on March 6, 2017. Section 393.150.2, RSMo 2000, provides that if a hearing cannot be concluded within the period of suspension, the Commission may extend the time of suspension for up to six months. In order for the Commission to have adequate time to complete the hearing process, the suspension period for the revised tariff sheet will be extended for 90 days.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets submitted under Tariff No. YE-2017-0052 by Union Electric Company d/b/a Ameren Missouri are further suspended until June 4, 2017.
