#### ORDER GRANTING INTERVENTION

On September 8, 2020, the Commission opened these files at the request of Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West for them to file their 2021 Triennial Integrated Resource Plans on April 1, 2021.

On February 16, 2021, the Commission received an intervention application from IBEW Local 304. More than ten days have elapsed since the application was filed, and no party has objected. Thus, the Commission will take up the application unopposed.<sup>1</sup>

The Commission finds that the interests of the applicant differs from those of the general public and may be adversely affected by a final order arising from this case. Furthermore, the Commission finds that allowing the applicant to intervene will serve the public interest. Therefore, the Commission will grant the application to intervene.

#### THE COMMISSION ORDERS THAT:

1. The application to intervene filed by IBEW Local 304 is granted.
