ORDER GRANTING LEAVE TO APPEAR *PRO HAC VICE*

On December 28, 2016, Joseph Halso (“Petitioner”) filed a petition for leave to appear and participate in this matter *pro hac vice* on behalf of Sierra Club. In the petition, Petitioner lists the courts of which he is a member in good standing. Petitioner has designated Henry B. Robertson as a member in good standing of the Missouri Bar, as local counsel. The petition includes a copy of the receipt from the Clerk of the Missouri Supreme Court to demonstrate compliance with Missouri Supreme Court Rule 6.01(m).
