## NOTICE OF TARIFF FILING AND ORDER ESTABLISHING TIME TO FILE RECOMMENDATIONS

On April 11, 2016, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (collectively, the "Company") filed applications for approval to discontinue the MEEIA Cycle 2 Home Appliance Recycling Rebate program. The Company desires to discontinue the tariffs for the Home Appliance Recycling Rebate program primarily due to recent changes in the marketplace inhibiting the ability to deliver cost effective savings to customers. The Company also filed revised tariffs to implement discontinuance of the program with an effective date of May 11, 2016.

The Commission will provide notice of this tariff filing to the parties in the Company's most recent rate cases, File Nos. ER-2014-0370 and ER-2016-0156. In addition, the Commission will establish a date for the filing of applications to intervene, direct its Staff to file a recommendation about the tariff, and establish a date for the filing of recommendations by other parties.

#### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order to all parties to File Nos. ER-2014-0370 and ER-2016-0156.

2. Any appropriate person or entity wishing to apply to intervene shall do so no later than April 18, 2016.

3. The Commission's Staff shall file a recommendation regarding Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company's tariffs no later than April 22, 2016.

4. Any other party wishing to file a recommendation regarding Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company's tariffs shall do so no later than April 22, 2016.

5. This order shall be effective when issued.
