The Staff of the Commission (Staff) was previously ordered to file a status report, including whether Staff intends to file a complaint.

On November 17, 2025, Staff filed a status report on this matter requesting additional time to January 16, 2026, to file a further status report and to state its intentions regarding a complaint. The additional time is requested for Summit Natural Gas of Missouri, Inc. (SNGMO) to complete agreed upon changes to its plans and procedures. SNGMO indicated to Staff that it is targeting having the proposed changes completed by the end of the year.

The Commission finds Staff's request to be reasonable and will grant it.

1. No later than January 16, 2026, Staff shall file a status report on this matter, including whether it intends to file a complaint against Summit Natural Gas of Missouri, Inc.
