**THIRD ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE
STAFF RECOMMENDATION AND COMMENTS**

On February 26, 2018, Union Electric Company d/b/a Ameren Missouri and all the other parties to this proceeding (“Movants”) filed a joint motion for an extension of time to file Staff’s recommendation regarding Ameren Missouri’s application in this matter. Movants request that the deadline be extended until March 26, 2018 in order to conduct additional discovery and negotiations regarding a possible settlement. Movants state that Ameren Missouri will extend the effective date of its tariff from March 26, 2018 to April 25, 2018. The Commission finds the request reasonable and will grant the motion.

THE COMMISSION ORDERS THAT:

1. Movants’ Joint Motion for Extension of Time to File Recommendations is granted. The deadline for filing a Staff recommendation is extended until no later than March 26, 2018.
2. The deadline for any party wishing to comment on the application submitted by Union Electric Company d/b/a Ameren Missouri is also extended until no later than March 26, 2018.

3. This order shall be effective when issued.
