On October 3, 2025,¹ Staff filed *Staff's Gas Incident Report* (Report). The Report stated that Staff found violations of the Commission's pipeline safety standards and provided eight recommendations related to those violations. Within the recommendations, Staff requested that the Commission order Spire to file an action plan, including the timeframe for implementation of Spire's proposed resolutions for each of the recommendations and updates every six months as to how the plan has been effectuated. Staff also requested approval to report the incident to the Missouri Attorney General's Office (AGO) for purposes of further action by the AGO.

On November 14, Spire responded, agreeing to all but the fourth recommendation. In its *Response to Gas Incident Report*, Spire also requested the opportunity to provide suggestions on any cover document accompanying the Report if ordered to be issued to the AGO. Accordingly, the Commission will direct Staff to respond to Spire's concerns with recommendation four, will approve Staff providing a public copy of the incident report to the AGO with Spire's suggestions for any cover document, and will direct Spire to file an action plan in this docket.

THE COMMISSION ORDERS THAT:

- 1. No later than December 4, 2025, Staff shall file a response to Spire's concerns with recommendation four.
- 2. No later than January 9, 2026, Spire shall file an action plan including the timeframe for implementation of its responses to each of the recommendations.
- 3. Spire shall file a status report every six months including progress of implementation of the action plan.
- 4. With Spire's suggestions for any cover document, Staff may provide a public copy of the incident report to the Missouri Attorney General's Office.
 - 3. This order is effective when issued.
