ORDER GRANTING MOTION TO AMEND APPLICATION AND DIRECTING FILING OF STAFF RECOMMENDATION

On April 18, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application to acquire the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge System). The Staff of the Commission (Staff) was ordered to file a recommendation regarding the application.

On September 25, 2024, the Commission granted a request to suspend the filing of a recommendation in anticipation of the application being amended. On November 7, 2025, Confluence Rivers filed a *Motion for Leave to Amend Application* (Motion). The Motion sought to substitute the application's Paragraph 14 regarding rates and substitute the economic feasibility study.

The Commission set a time for responses to the Motion, but no responses were received. The Commission finds the unobjected-to Motion's request to amend the application reasonable and will grant it.

The Commission also ordered its Staff to file a pleading indicating a date when its recommendation on Confluence Rivers' application as amended could be expected. Staff responded that it expects to file its recommendation no later than January 15, 2026. The Commission finds the date reasonable and will order Staff to file its recommendation by that date.

THE COMMISSION ORDERS THAT:

- 1. The Motion is granted. The application shall be amended as requested, including the substitution of the feasibility study (Amended Appendix F-C shall be substituted for Appendix F-C).
 - 2. Staff shall file its recommendation no later than January 15, 2026.
 - 3. This order shall be effective when issued.
