ORDER AMENDING PROCEDURAL SCHEDULE

On August 17, 2018, the Staff of the Missouri Public Service Commission, Union Electric Company d/b/a Ameren Missouri, the Office of the Public Counsel, the Empire District Electric Company, and the Missouri Division of Energy (collectively referred to as the "joint movants") filed a joint motion to amend the procedural schedule in this matter. The joint movants stated that the other intervenors, with the exception of the Missouri Industrial Energy Consumers (MIEC), affirmatively stated no opposition to the motion. MIEC had not responded to the joint movants at the time of the filing.

The proposed amendments merely extend the deadlines for filing of testimony and other filings prior to the hearing dates which remain unchanged. Thus, no party is prejudiced by the amendments as proposed. The Commission will amend the procedural schedule as set out below.
