ORDER SETTING PREHEARING CONFERENCE

On June 2, 2025, the Staff of the Commission (Staff) filed notice that, on that date, it started its third prudence review of costs associated with Evergy Metro, Inc. d/b/a Evergy Missouri Metro(Evergy Missouri Metro), f/k/a Kansas City Power & Light Company (KCP&L) Greater Missouri Operations Company (GMO) Cycle 3 energy efficiency programs and its first MEEIA prudence review of the cost associated with its Cycle 4 energy efficiency programs.

Commission Rule 20 CSR 4240-20.093(11)(B) requires Staff to file notice within 10 days of starting its prudence audit. The rule also requires Staff to file its recommendation regarding its examination and analysis no later than 150 days after Staff initiates review. Staff filed its report and recommendation on October 30, 2025. On November 3, 2025, Evergy filed a Request for Hearing.

It is now appropriate to reschedule the Prehearing Conference, so the parties may discuss whether a hearing is needed and, if so, what dates would be appropriate for that hearing and what dates would be appropriate for a prehearing conference. A prehearing conference will be ordered for December 4, 2025 at 2:00 p.m. by Webex.

THE COMMISSION ORDERS THAT:

1. The Commission will convene a prehearing conference on December 4, 2025, at 2:00 p.m., via WebEx. The Commission will send parties information needed to access WebEx for the conference via email.
2. This order shall be effective when issued.
