## ORDER DIRECTING FILING

On January 15, 2021, Liberty Utilities (Missouri Water) LLC ("Liberty Water") submitted an application requesting authority to issue additional long-term unsecured debt and to incur, pay, and amortize the debt issuance expense and/or a proportional share of fees associated with the debt.

On March 1, 2021, Staff filed a recommendation that the Commission grant the application, with specified conditions. On March 3, 2021, the Commission directed Staff to clarify its recommendation and file a corrected memorandum, if necessary.

On March 5, 2021, Liberty Water filed an amendment to its application. In lieu of the previously required clarification or correction, the Commission will direct Staff to file a recommendation regarding Liberty's Water's amended application or a status report stating when it expects to file such a recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than March 15, 2021, Staff shall file a recommendation regarding Liberty Water's amended application or a status report stating when it expects to file such a recommendation.
2. Staff's obligation to file a clarification of Staff's recommendation, filed on March 1, 2021, is vacated.

3. This order shall be effective when issued.
