# ORDER AUTHORIZING ANNUAL TRUE-UP ADJUSTMENT TARIFF TO BECOME EFFECTIVE

Issue Date: November 19, 2025 Effective Date: December 1, 2025

On October 15, 2025, The Empire District Electric Company d/b/a Liberty submitted a revised tariff sheet for the annual true-up of its Securitized Utility Tariff Charge Rider (SUTC). That tariff sheet bears a December 1, 2025, effective date.

Section 393.1700.2(3)(e), RSMo, requires Liberty to, at least annually, file a petition or letter applying a formula-based true-up mechanism adjusting the SUTC.

The Commission directed its Staff to file a recommendation about Liberty's true-up adjustment tariff sheet and set a time for other responses. Staff filed a recommendation on November 4, 2025, stating that it had reviewed Liberty's workpapers for mathematical or clerical errors in the calculation of the securitized utility tariff charge and found no mathematical or clerical errors. Staff recommended that Liberty's true-up adjustment tariff sheet should take effect on December 1, 2025. The Commission received no other responses to Liberty's true-up adjustment tariff sheet.

The Commission reviewed the tariff sheet and Staff's recommendation and finds that the true-up adjustment tariff sheet shall become effective on December 1, 2025. Accordingly, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the tariff sheet.

# THE COMMISSION ORDERS THAT:

1. In accordance with the statutory requirements set out in Section 393.1700.2(3)(e), RSMo, the Commission finds that Liberty has fulfilled the annual filing requirement for 2025 of making a formula-based true-up mechanism for expeditious periodic adjustments in the securitized utility tariff charges and has filed such with the Commission, therefore, the Commission makes no other findings at this time and the following tariff sheet filed by Liberty on October 15, 2025, and assigned Tracking No. JE-2026-0055, shall become effective on December 1, 2025:
