**NOTICE THAT TARIFFS WILL BE ALLOWED TO GO INTO EFFECT**

Issue Date: July 28, 2021

On July 2, 2021, The Empire District Electric Company, a Liberty Utilities company (Liberty) filed Tariff No. YE-2022-0004 to further its implementation of a community solar pilot program.<sup>1</sup> At Staff's request, Liberty- Empire filed substitute sheets on July 16.

The substitute tariff sheets remove the upfront subscriber fee of \$25. They also state that the solar facility to be used for the program has been completed. Staff filed a recommendation on July 19, asking the Commission to allow the tariff to go into effect by operation of law. No party has objected.

Tariff No. YE-2022-0004, filed on July 2, as updated by substitute sheets filed on July 16, will be allowed to go into effect by operation of law on August 1.
