On May 24, 2022, The Empire District Electric Company, a Liberty Utilities company (Empire-Liberty) filed a tariff to implement a second Community Solar Pilot Program facility. The tariff, denominated Tracking No. YE-2022-0261, bore an effective date of July 1.

On June 13, 2022, the company extended the tariff's effective date to August 1, 2022. The Commission will order responses.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a Recommendation on Tariff No. YE-2022-0261 no later than July 12, 2022.
2. Any response to the Staff Recommendation shall be filed no later than July 14, 2022.
3. This order shall be effective when issued.
