ORDER APPROVING REQUEST TO APPROVE TECHNICAL RESOURCE MANUAL AND DEEMED SAVINGS TABLE

Issue Date: November 21, 2025

Effective Date: December 1, 2025

On November 10, 2025, Union Electric Company d/b/a Ameren Missouri filed a *Request to Approve Technical Resource Manual and Deemed Savings Table and Motion for Expedited Treatment* (Motion). Ameren Missouri asks for expedited treatment so that the proposed revisions to the Technical Resource Manual (TRM) can go into effect with the program year beginning January 1, 2026. Ameren Missouri states that it consulted with the Commission's Staff (Staff), and that Staff had no concerns.

The Commission allowed parties until November 20, 2025, to object to Ameren Missouri's Motion. No party responded. Thus, the Commission will take up the Motion unopposed.

The Commission finds the Motion reasonable. The Commission will grant the Motion.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri's Motion is granted.
2. The revisions to the TRM (Appendices G, H and Appendix I) and Deemed Savings Table (Appendix F) are approved.

3. This order shall be effective on December 1, 2025.
