On November 10, 2025, Union Electric Company d/b/a Ameren Missouri filed a Request to Approve Technical Resource Manual and Deemed Savings Table and Motion for Expedited Treatment (Motion). Ameren Missouri asks for expedited treatment so that the proposed revisions to the Technical Resource Manual (TRM) can go into effect with the program year beginning January 1, 2026. Ameren Missouri states that it consulted with the Commission's Staff (Staff), and that Staff had no concerns.
