Re: Notification of Merger of Engage Holdings, LLC dba iQventures into InContact, Inc.

Dear Secretary Dippell,

inContact, Inc. ("inContact") and Engage Holdings, LLC dba iQventures ("Engage") (collectively, the "Parties"), by undersigned counsel, hereby notify the Missouri Public Service Commission ("Commission"), of the merger of Engage into inContact ("Transaction"), which is scheduled to occur on or around December 31, 2025.

It is the Parties' understanding that formal Commission approval of the Transaction is not required. Accordingly, the Parties submit this letter for informational purposes only to ensure the continuing accuracy of the Commission's records.

#### I. DESCRIPTION OF THE PARTIES

#### A. Engage Holdings, LLC dba iQventures

Engage is a privately-held Ohio limited liability company that provides nomadic Interconnected Voice Over Internet Protocol ("I-VoIP") and internet access solutions on a resale basis to enterprise customers. Engage is registered with the Commission as an I-VoIP provider, Certification No. DA-2017-0184; certified on January 14, 2017.

#### B. InContact, Inc.

inContact is a Delaware limited liability company with its principal place of business located at 75 West Towne Ridge Parkway Tower 1, Sandy, UT 84070. inContact is currently Engage's affiliate. Upon the closing of the Transaction, Engage will merge into inContact, and Engage will cease to exists as a separate legal entity.

inContact holds the following certifications with the Commission:

- Telephone Interconnected VoIP Certification No. DN-2016-0071; certified on September 28, 2015;
- Telephone IXC Certification No. TN-2016-0070; certified on October 1, 2015;
- Telephone CLEC Certification No. TN-2016-0070; certified on October 1, 2015.

inContact holds PSC registrations and authorizations in additional states.

Members of inContact's management team have extensive experience operating regulated telecommunications companies. inContact is well-qualified to continue conducting Engage's business and serving Engage's customers.

#### II. DESCRIPTION OF THE TRANSACTION

On or around December 31, 2025, Engage will merge into its affiliate, inContact as part of a corporate restructuring. As a result, all services will be provided by inContact, and invoices will be issued under the inContact name. The transaction will in no way diminish the availability, quality, and affordability of the I-VoIP services offered to Engage's Missouri customers.

The proposed Transaction will serve the public interest. It will result only in internal corporate restructuring. No material changes to the rates, terms and conditions of service offered by Engage to its customers are expected to occur as a result of the Transaction.<sup>1</sup>

Customer invoices will be issued under inContact's name, but other than that, most Engage subscribers will not notice that their provider has undergone an internal corporate restructuring. Notwithstanding the foregoing, Engage will provide its customers with at least thirty (30) days written notice of the corporate restructuring. A sample notice is included hereto, as Exhibit A.

Accordingly, this Transaction will be, for all practical purposes, imperceptible to the customers of Engage. The Transaction also will not adversely affect competition for the provision of telecommunications in the jurisdictions currently served by Engage because all of the customers served by Engage have, and following consummation of the Transaction will continue to have, access to competitive alternatives.

No material changes in Engage's existing management and operational personnel are planned as a result of the Transaction, and such management and operational personnel are currently expected to continue to actively participate in the day-to-day operations of Engage.

In sum, the transaction will serve the public interest by preserving and enhancing Engage's strengths without posing any threat of anticompetitive effects or other public interest harms, and it will be largely invisible to consumers. For the foregoing reasons, consummation of the Transaction proposed herein will serve the public interest.
