**NOTICE OF CLOSING
AND REQUEST THAT CERTIFICATE AND TARIFF BE CANCELLED**

COMES NOW RDG Development, LLC (RDG), by and through counsel, and, as its Notice of Closing and Request that Certificate and Tariff be Cancelled, states the following to the Missouri Public Service Commission (Commission):

1. The Commission Order Approving Application (Order) in this case, among other things, directed that the “parties shall submit notice to the Commission regarding evidence of the transfer of assets to Greenwood Hills Homeowners Association within three business days after the transfer and Commission approval is effective.”


2. RDG hereby states that the subject assets were transferred to the Greenwood Hills Homeowners Association on November 2, 2010. Evidence of this transfer, in the form of a copy of the relevant warranty deeds, is attached hereto as **Appendix A**.

3. The Order further directed that “the parties shall file a motion in this case requesting that the certificate of convenience and necessity held by, and sewer tariff YS-2010-0397 on file for, RDG Development, LLC be cancelled.”

4. Because the proposed transaction has been closed and RDG no longer has the assets necessary for the provision of sewer services in its previously certificated territory, RDG requests that its certificate of convenience and necessity and sewer tariff YS-2010-0397 be cancelled.

WHEREFORE, RDG respectfully requests that the Commission issue its order accepting the notice of closing and cancelling RDG's certificate and tariff, as requested herein.


