ORDER APPROVING PURCHASED GAS ADJUSTMENT TARIFF

Issue Date: November 21, 2025 Effective Date: November 26, 2025

On November 12, 2025, ¹ Spire Missouri Inc. d/b/a Spire filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment (PGA) for its eastern Missouri (Spire East) and western Missouri (Spire West) operating divisions. The tariff sheets bear an effective date of November 26 and have been assigned Tracking No. JG-2026-0069. The tariff sheets were filed to reflect changes in Spire's Current Purchased Gas Adjustment (CPGA) factors as a result of estimated changes in the cost of natural gas for Spire East and Spire West. Also included in Spire's filing is the annual change to the Actual Cost Adjustment (ACA).

Spire estimates its proposed tariff sheets will increase its charges for gas from \$0.52486 to \$0.61674 per Ccf² in the Spire East service area and from \$0.62139 to \$0.67976 per Ccf in the Spire West service area. Compared to existing rates, Spire estimates that the average monthly bill of the typical residential customer would increase by \$5.79 (6.43%) for the Spire East service area and by \$3.33 (3.55%) for the Spire West service area, although such bill impacts may be more or less, depending on a customer's actual usage, which is primarily affected by weather. Spire cites higher gas prices as the reason for the increases.

² Ccf is a volume measurement of natural gas and equals 100 cubic feet of natural gas.

The Commission directed its Staff (Staff) to file a recommendation no later than November 19 and set that date as the deadline for responses to Spire's filing and Staff's recommendation. Staff filed its recommendation and supporting memorandum on November 17. No other responses were filed by the deadline.

Staff states that the present case, Case No. GR-2026-0127, was established to track Spire's PGA factors to be reviewed in its 2024-2025 ACA filing. Case No. GR-2024-0341 was established to track Spire's PGA factors to be reviewed for the 2023-2024 ACA period. Staff recommends the rate changes proposed in the present case be approved by the Commission on an interim basis, subject to refund, and pending final Commission decisions in this case and Case No. GR-2024-0341. Staff also requested permission to file its results and recommendations regarding the information included in this ACA filing on or before December 15, 2026.

The Commission has reviewed the proposed tariff sheets and Staff's verified recommendation. The Commission finds that the proposed tariff sheets conform to Spire's Commission-approved PGA tariff. In addition, because Spire's PGA clause allows for PGA change filings to take effect after ten business days, good cause has been shown pursuant to Section 393.140(11), RSMo 2016, to permit the tariff to become effective on less than 30-days' notice. The Commission concludes the proposed tariff sheets should be approved to become effective on November 26, on an interim basis, subject to refund, and pending final Commission decision in this case and Case No. GR-2024-0341. For the same reasons that the tariff sheets will take effect in less than 30 days, the Commission finds it reasonable for this order to become effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The tariff sheets, assigned Tracking No. JG-2026-0069, are approved on an interim basis and subject to refund, pending final Commission decisions in this case and in Case No. GR-2024-0341. The tariff sheets approved are:
