ORDER GRANTING REQUEST FOR MEDIATION, SUSPENDING THE PROCEDURAL SCHEDULE, AND APPOINTING A MEDIATOR

The Commission grants Respondent, Missouri-American Water Company's, request for mediation. On February 2, 2021, Missouri-American Water Company requested mediation. Complainant, Dr. Sarah Nangle, agreed to mediation during an informal videoconference with the parties on March 5, 2021.

Commission Rule 20 CSR 4240-2.125(2)(C) suspends the procedural schedule during the mediation process; the deadlines imposed by regulation or order are tolled during mediation.

The Commission will appoint a mediator as allowed in Commission Rule 20 CSR 4240-2.125(2)(B). The mediator will be in touch with the parties regarding the details of mediation.

THE COMMISSION ORDERS THAT:

1. Missouri-American Water Company's request for mediation is granted.
2. The procedural schedule is suspended during mediation.
3. Paul Graham, Regulatory Law Judge, is appointed as mediator.

4. This order is effective when issued.
