ORDER GRANTING EXTENSION OF TIME TO FILE COMMENTS

The Commission opened this working case to examine the wildfire mitigation preparedness of Commission-regulated utilities in the state of Missouri; to gather information from utility stakeholders regarding current wildfire mitigation preparedness; and to develop best practices. On October 31, 2025, the Commission issued an *Order Setting Time for Responses* directing that responses to various best practices for wildfire response and recovery for electrical and gas corporations be filed no later than December 1, 2025.

On November 19, 2025, Grain Belt Express, LLC, requested additional time, until December 12, 2025, to file its comments. The Commission will grant the extension for Grain Belt Express and any other commenter.

THE COMMISSION ORDERS THAT:

1. Any comments on the electric or gas utility wildfire emergency response and recovery plans shall be filed no later than December 12, 2025.
2. This order is effective when issued.

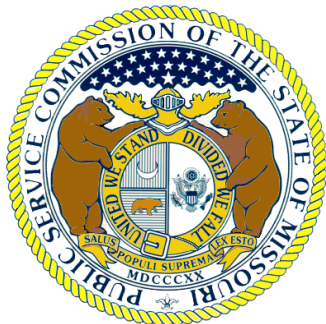
