## ORDER GRANTING APPLICATION TO INTERVENE

Issue Date: November 24, 2025

On October 24, 2025, The Empire District Electric Company d/b/a Liberty filed the above-referenced application, proposing to construct a 250 MW combustion turbine generator.

The Commission directed notice and set a deadline for applications to intervene of November 12, 2025. Renew Missouri Advocates d/b/a Renew Missouri filed a timely application to intervene. More than ten days have passed since the application was filed and no one has objected to the application.<sup>1</sup> After considering the unopposed application to intervene, the Commission finds that Renew Missouri has an interest that is different from that of the general public and allowing it to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

**THE COMMISSION ORDERS THAT:**

1. The application to intervene of Renew Missouri Advocates d/b/a Renew Missouri is granted.
