<u>BACKGROUND</u>: These Supplemental Data Requests are submitted in order to aid in determining whether Grain Belt Express LLC (Grain Belt) has exercised the authority conferred by the Certificate of Convenience and Necessity (CCN) in this case within two years of the Commission's Report and Order of October 12, 2023, effective November 11, 2023.

DEFINITIONS:

- 1. "CCN Order" means the Commission's Report and Order issued in this case on October 12, 2023.
- 2. "Install transmission facilities" has the same meaning as used in the CCN Order at page 71, lines 9-24 of the indented quotation from the Financing Conditions.
- 3. "Phase I" and "Phase II" have the same meanings as used in the CCN Order.

DATA REQUESTS:

DR 1. Please state whether Grain Belt has installed any of the transmission facilities authorized to be installed under the CCN Order.

- DR 2. If the answer to the preceding item is anything other than an unqualified "no", please (a) describe each of the individual component facilities which have been installed; (b) state the date(s) on which each such component was installed; (c) state the installed book cost of each such component; (d) state the approximate linear distance along the proposed right-of-way of each such component; and (e) state whether or not that component was installed on property owned in fee by Grain Belt.
- DR3. Please state whether Grain Belt has contributed to the decommissioning fund addressed at page 74 of the CCN Order.
- DR4. If the answer to the preceding item is anything other than an unqualified "no", please state the following: (a) the date on which each such contribution was made to the decommissioning fund; (b) the dollar amount or dollar value of each such contribution; (c) a description of the portion of the project related to each such contribution; and (d) provide a copy of the document(s) evidencing each such contribution.
- DR5. Please state whether Grain Belt has obtained commitments for funds in an amount equal to or greater than the total cost to build the entirety of Phase I of the Project.
- DR6. Please state whether Grain Belt has obtained commitments for funds in an amount equal to or greater than the total cost to build the entirety of Phase II of the Project.

DR15. Please list and briefly describe each activity, including the date(s) when undertaken, which Grain Belt has taken in an effort to exercise the authority conferred to it by the CCN Order.
