ORDER APPROVING STAFF'S PRUDENCE AUDIT REPORT

Issue Date: March 17, 2021 Effective Date: April 16, 2021

This case was opened on September 3, 2020, to consider Union Electric Company d/b/a Ameren Missouri's eighth fuel adjustment clause prudence review. On February 26, 2021, the Commission's Staff filed a report regarding its review in which it found no incidence or evidence of imprudence by Ameren Missouri for the period of October 1, 2018 through May 31, 2020. Ten days have passed since the filing of Staff's report and no requests for hearing were filed.¹

The Commission has considered Staff's unopposed report and recommendation. In evaluating prudence, Staff reviewed whether a reasonable person would find that both the information Ameren Missouri relied on, and the process Ameren Missouri employed when making the decision under review, were reasonable based on the circumstances at the time the decision was made, without the benefit of hindsight. During its review, Staff found no evidence of imprudence by Ameren Missouri.

The Commission finds Staff's report and recommendation regarding its prudence review of Ameren Missouri's fuel and purchased power costs and off-system sales revenue associated with its fuel adjustment clause to be reasonable, and will approve it.
