## ORDER SETTING ON-THE-RECORD PRESENTATION

On June 30, 2020, Missouri-American Water Company (Missouri-American) submitted tariff sheets designed to implement a general rate increase for water and sewer services. On March 5, 2021, after the procedural scheduled was suspended, the parties, with the exception of The Empire District Electric Company, Municipal League of Metro St. Louis and Triumph Foods, LLC, filed a *Stipulation and Agreement*. More than seven days has passed and no party has objected to the agreement. The Commission will schedule an on-the-record presentation for the parties to have the opportunity to present the agreement to the Commission and to answer any Commission questions concerning the agreement.

### THE COMMISSION ORDERS THAT:

1. An on-the-record presentation for the parties to present the *Stipulation and Agreement* and to respond to Commission questions is scheduled for March 29, 2021, at 1:30 p.m. to be held by video and teleconference via WebEx. The presentation will also be live-streamed via the Commission's website at psc.mo.gov. Interested persons who will not be actively participating in the presentation should access it via the live stream.

The link and access code to participate in the presentation via WebEx will be emailed to counsel for the parties.

3. This order shall be effective when issued.
