NOTICE REGARDING PROCEDURES AT WORKSHOP

On March 11, 2021, the Commission ordered Missouri's investor-owned natural gas utilities (IOUs) to present at a March 23, 2021 workshop additional information related to potential consequences and options to mitigate the impact of the February 2021 extreme cold weather event. Questions have been raised about procedures to be followed at that workshop meeting. This notice will address those questions.

1. Participation in the workshop will be virtual, through WebEx, as indicated in a previous order. The workshop will also be live-streamed through the Commission's website in the same manner as the Commission's weekly agenda meetings are live-streamed. Anyone who wishes to watch the proceeding without participating is encourage to watch the live-stream.
2. If any participating IOU wants to use a power-point presentation they must submit the power-point presentation to the presiding judge no later than the day before the workshop.
3. The presiding judge, the Commissioners, and members of the Commission's Staff may question representatives of the IOUs. Other participants in the workshop will not be allowed to directly question the representatives of the IOUs,

but they may submit questions to a chat moderator through WebEx's chat function. The chat moderator, who will be a member of Staff, will decide whether it is appropriate to ask the questions to the IOU representatives at the workshop. Staff may respond to the questions outside the workshop if it is more appropriate to do so.
