ORDER DIRECTING CORRECTED FILING

On July 20, 2020, Missouri-American Water Company (MAWC) applied for a certificate of convenience and necessity to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in and around Hallsville, Missouri. On January 20, 2021, the Commission issued its *Order Setting Procedural Schedule* and set deadlines for the filing of prepared testimony.

Among other requirements, testimony filed with the Commission must be consecutively page-numbered and indicate page numbers at "the bottom right-hand corner or bottom center beginning with the first page as page 1."¹ The Commission will direct MAWC to file a corrected version of Mr. Matt Horan's surrebuttal testimony, filed on March 16, 2021, to comply with the page-numbering requirement.

THE COMMISSION ORDERS THAT:

1. No later than March 23, 2021, MAWC shall file a corrected version of Mr. Horan's surrebuttal testimony to add page numbers. No other additions or revisions are authorized by this order.
