- 1. At the Commission's agenda meeting on November 5, 2025, the Commission Chair and Commissioners encouraged the signatories to revisit the Non-Unanimous Global Stipulation and Agreement filed on October 6, 2025, in the above-captioned case.
- 2. Parties' initial post-hearing briefs are due December 1, 2025, and reply briefs are due December 8, 2025.
- 3. In light of the agenda meeting case discussion, and to allow time to finalize and file an amended settlement agreement, the Parties request that the filing deadlines for both the initial post-hearing briefs and the reply briefs be further extended. Specifically, the Parties request that the filing deadline for the initial post-hearing brief be extended until December 5, 2025, and the filing deadline for reply briefs be extended until December 15, 2025.
