### ORDER SETTING PROCEDURAL CONFERENCE

On September 23, 2024, the Manager of the Manufactured Homes and Modular Units Program of the Missouri Public Service Commission filed a complaint with the Commission against Stephen L. Johnson d/b/a Colony Cove, Inc. and/or Sequiota Investments, Inc. (Respondent). On November 21, 2024, Respondent filed an answer.

An evidentiary hearing was scheduled for October 28 and October 29, 2025. On October 6, 2025, Respondent requested a continuance to retain new counsel, which was granted.

On November 25, 2025, counsel for Respondent filed *Entry of Appearance and Request for Procedural Conference* (Motion). The Motion requested a procedural conference to discuss the status of the case and to reschedule the evidentiary hearing and related deadlines. The Commission finds the Motion reasonable and will grant it.

#### THE COMMISSION ORDERS THAT:

- 1. All parties shall appear at a procedural conference held on December 9, 2025, beginning at 9:00 a.m.
- 2. The procedural conference will be held in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The building meets accessibility standards required by the Americans with Disabilities Act.
