SPIRE MISSOURI FISCAL YEAR 2026 REPORT

COMES NOW Spire Missouri Inc. ("Spire Missouri" or "Company"), and, as required by the *Stipulation and Agreement* (the "Stipulation") states as follows:

- 1. Under the Stipulation, Spire Missouri is required to annually commit, starting in fiscal year 2024 and continuing for five (5) years until fiscal year 2028, \$300,000 to community action agencies ("CAAs") for weatherization efforts and \$200,000 to either the Payment Partner Program or the Critical Needs Program for low-income bill assistance. However, for fiscal year 2026, the Signatories agreed that Spire Missouri would pay the \$300,000 to Missouri Community Action Network ("Missouri CAN"), which will then disperse these funds to CAAs for weatherization efforts at its discretion.
- 2. Under the Stipulation, annually on December 1, starting on December 1, 2023 and ending on December 1, 2027, Spire Missouri is required to file a report, supported by affidavit, which includes the following information:
 - a. The dates, amounts, and methods of payments made under this paragraph during the prior year and cumulatively;
 - b. For the weatherization funds and based on the individual reports from the CAAs, Spire Missouri will report on how many low-income families benefited in the prior 12 months and will estimate how many low-income families are expected to benefit from those funds in the next 12 months;

- c. For the bill assistance programs, Spire Missouri will report on which program the funding was contributed to, and, if feasible, the estimated number of low-income families that received such funding in the prior 12 months and the estimated number of low-income families that will receive such funding in the next 12 months; and
- d. Identification of all relevant facts related to any non-compliance with this paragraph and explaining such non-compliance.
- 3. Attached as **Appendix 1** is the Affidavit of David Yonce, which verifies that everything stated in this report is true to the best of his knowledge and belief.
- 4. On October 9, 2025, \$300,000 was dispersed to Missouri CAN, which will then disperse funds to CAAs for weatherization efforts at its discretion. As Spire Missouri has provided the weatherization funds to Missouri CAN, which will disperse the funds at its discretion, Spire Missouri is unable to report on how the funding will be used and how many families are expected to benefit. Spire Missouri will meet with Missouri CAN after the end of fiscal year 2026 to determine, if feasible, how the funding was used and how many families benefited, and include that information in the December 1, 2026 report.
- 5. Attached as **Appendix 2** is the weatherization funding fiscal year 2025 report, which provides the number of families that benefited in fiscal year 2025. This will also be provided at the December annual weatherization meeting. To date, \$900,000 has been allocated to for weatherization efforts.
- 6. On October 9, 2025, Spire Missouri dispersed \$200,000 pursuant to this Stipulation to the United Way of Greater St. Louis ("UWGSL") to be used in the Critical Needs Program. In total, the Company provides \$700,000 annually to the United Way for

the Critical Needs Program.¹ In fiscal year 2025, 369 customers received bill assistance from the Critical Needs Program administered by UWGSL. To date, \$600,000 has been dispersed to UWGSL for the Critical Needs Program as part of this Stipulation.

WHEREFORE, Spire Missouri respectfully requests that the Commission accept this report.

Stipulation & Agreement

- In accordance with the Stipulation & Agreement reached in Case No. GR-2021-0127, \$300,000 in weatherization funding was made available to five community action agencies and one non-profit in Spire's Missouri East (MOE) service territory.
- Funding available October 1, from FY 23 to FY 27.
- **Due to federal funding uncertainty, the Signatories decided to redirect FY2026 funds to MOCAN to disburse.
- Funds are provided with the express purpose of enabling D.O.E. weatherization (WX) funding to homes that would otherwise be "deferred" or "passed over"
- Funds can also be directed at each agency's discretion, to the following:
 - Outreach Efforts
 - WX training & certification for agency employees
- > If the above has been exhausted, funds can also be redirected to:
 - ➤ Utility bill credits and/or arrearages

Program Strengths, Weaknesses, Opportunities

Strengths

- > 14 Families Helped
- All deferrable repairs are eligible to approved Spire WX customers
- ➤ The ability to direct funds towards Outreach Flyers/Mailers
- Majority of the projects came from the agencies/non-profit where Spire has a larger customer base

Weaknesses

- ➤ Where Spire has a smaller customer base, there is a struggle to find customers that qualify for the WX program
- Uncertainty in funding from D.O.E. does not allow agencies/non-profit to plan properly
- Staffing cuts reduces the number of project opportunities
