Great Plains Energy, Inc. filed its agreement<sup>1</sup> to Staff's motion to modify the times to answer or object to data requests ("motion").<sup>2</sup> The time to answer or object to data requests is subject to agreement of the parties to data requests, and to the Commission's order. <sup>3</sup> Therefore, the Commission will make the following orders.

#### THE COMMISSION ORDERS THAT:

- 1. The Staff's Motion to Shorten Time to Respond and Object to Data Requests and Motion for Expedited Treatment is granted.
  - 2. The interval allowed to answer data requests shall be eight days.
  - 3. The interval to object to data requests shall be five days.
  - 4. This order shall be effective when issued.
