ORDER DISCONTINUING REPORTING REQUIREMENT

This order relieves Union Electric Company d/b/a Ameren Missouri from the requirement that it file a quarterly report on the completion of projects related to the retirement of its Rush Island Energy Center (Rush Island).

On February 20, 2025, the Commission reduced Ameren Missouri's reporting requirement regarding the completion of projects related to Rush Island's retirement from monthly to quarterly.

On August 13, 2025, Ameren Missouri filed its quarterly report along with a motion to cease reporting. Ameren Missouri's motion stated that it has completed the projects it was required to file a quarterly report about. On November 13, 2025, Ameren Missouri filed another quarterly report and motion to cease reporting.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. No party filed a response to Ameren Missouri's motion to cease filing quarterly reports.

The Commission has considered Ameren Missouri's request to cease quarterly reporting about the retirement of Rush Island and finds the request reasonable. The Commission will grant the request.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri is no longer required to file a quarterly report concerning the completion of projects related to the retirement of Rush Island.
2. This order shall be effective on December 2, 2025.

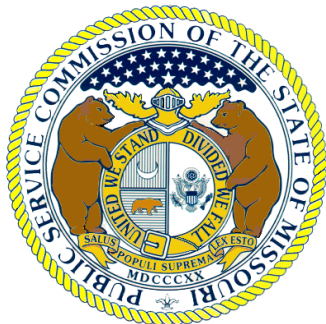
