ORDER DIRECTING THE FILING OF PROPOSED PROCEDURAL SCHEDULE AND GRANTING INTERVENTION

Issue Date: December 3, 2025

The Commission held a procedural conference on December 2, 2025. At that conference the parties indicated that they would be able to file a proposed procedural schedule by January 22, 2026. The Commission will direct its Staff to consult with the other parties and submit a proposed procedural schedule with dates for a local public hearing, or a status report.

On November 25, 2025, Missouri Joint Municipal Electric Utility Commission (MJMEUC) filed an application to intervene. No party objected to MJMEUC's intervention at the procedural conference. The Commission will grant the intervention.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a proposed procedural schedule or status report on behalf of the parties no later than January 22, 2026.
2. MJMEUC's application to intervene is granted.

3. This order is effective when issued.
