## ORDER DIRECTING FILING

On November 14, 2025,<sup>1</sup> Spire filed its *Response to Staff's Gas Incident Report* agreeing to all but the fourth recommendation made in Staff's Report. The Commission directed Staff to respond by December 4. On December 3, Staff responded, amending the fourth recommendation, and requesting that Spire file its suggestions and the name of the Spire representative to copy on the email transmission to any questions of the Missouri's Attorney General's Office.

Accordingly, the Commission will direct Spire to respond to Staff's requests as set forth in Appendix A.

### THE COMMISSION ORDERS THAT:

1. No later than December 18, 2025, Spire shall file a response to Staff's amended recommendation four and file its suggestions and the name of the Spire representative to copy on the email transmission to any questions of the Missouri Attorney General's Office.
