## GRAIN BELT EXPRESS, LLC'S MOTION FOR EXTENSION OF TIME FOR ALL PARTIES TO FILE REBUTTAL TESTIMONY

Grain Belt Express LLC ("Grain Belt Express") hereby requests that the Commission issue an Order extending the deadline for all parties to file rebuttal testimony to December 12, 2025. In support of its Motion, Grain Belt Express states as follows:

- 1. On September 4, 2025, the Commission issued its *Order Setting Procedural Schedule, a Local Public Hearing, and Assignment of Exhibit Numbers* ("Order"). The Order established December 9, 2025 as the deadline for filing Rebuttal Testimony.
- 2. On December 8, 2025, the Staff of the Missouri Public Service Commission ("Staff") polled the other parties regarding whether there are objections to Staff's requests to extend the deadline for rebuttal testimony and for leave to file its rebuttal testimony in a report format. Grain Belt Express has no objections to Staff's requests, provided that the deadline for rebuttal testimony be extended to December 12, 2025 for all parties, and notified Staff of the same via e-mail on December 8, 2025.
- 3. On December 9, 2025, Staff filed its Motion and noted that it has no objection to the Commission extending the deadline for all parties, but Staff did not move the Commission for an Order extending the rebuttal testimony deadline for all parties. In the interests of fairness,

Grain Belt Express hereby moves the Commission for an Order extending the rebuttal testimony deadline to December 12, 2025 for all parties.

WHEREFORE, Grain Belt Express requests that the deadline for rebuttal testimony be extended to December 12, 2025 for all parties.
