On December 9, 2025, the Staff of the Commission (Staff) filed a request to extend the deadline for rebuttal testimony to December 12, 2025, and grant it leave to file a rebuttal report as its rebuttal testimony. Grain Belt Express LLC filed a response asking that the deadline for rebuttal testimony for all parties be extended to December 12, 2025.

The Commission will modify the procedural schedule.
