ORDER GRANTING EXTENSION

On December 5, 2025, White River and Liberty filed a *Stipulation and Agreement* (Stipulation) and asked that the Commission approve the Stipulation. The Stipulation states that its' signatories are White River and Liberty and that Staff Counsel and The Office of Public Counsel are not opposed to the Stipulation.

On December 9, 2025, the Office of Public Counsel filed a *Notice of Clarification and Motion for Extension* requesting the Commission grant a seven-day extension so they could review the Stipulation. In their Motion, the Office of Public Counsel, who is a valid party to the case, stated that it did not see the Stipulation before it was filed and was not part of the discussion regarding the Stipulation. The Commission will grant the extension for good cause.

THE COMMISSION ORDERS THAT:

1. The Commission will grant the *Motion for Extension* and give the Office of Public Counsel seven additional days to review the Stipulation.
2. Any objections to the Stipulation shall be filed no later than December 17, 2025.
3. This order shall be effective when issued.
