**COMES NOW** Missouri-American Water Company ("MAWC") and for its *Response to Staff Recommendation* states as follows to the Missouri Public Service Commission ("Commission"):


1. On September 24, 2025, MAWC filed applications seeking an expansion of its existing Certificates of Convenience and Necessity. The expansion would authorize MAWC to construct, install, own, operate, maintain, and otherwise control the water and sewer systems in various areas in Missouri.

2. On December 5, 2025, Staff filed its *Staff Recommendation* and supporting *Memorandum*. The *Staff Recommendation* and *Memorandum* recommended the Commission grant the request of MAWC for an expansion of a number of its existing Certificates of Convenience and Necessity.

3. MAWC has reviewed the proposed conditions and actions listed on page 8 of Staff's *Memorandum* and states that it has no objection to the proposed conditions and actions.

**WHEREFORE**, MAWC requests the Commission issue an order approving MAWC's *Application and Motion for Waivers* and granting MAWC CCNs as recommended in Staff's Recommendation, and for such other and further relief as deemed appropriate in the circumstances.
