- 1. On December 12, 2025, the OPC and other parties filed Rebuttal Testimony in this matter. (Docs. 40-44). In particular, the OPC filed Dr. Geoff Marke's Rebuttal Testimony in both public and highly confidential versions. (Doc. 40).
- 2. The OPC became aware that the page numbers and headings were inadvertently removed and a stray number was added to the Table of Contents in the highly confidential version of Dr. Marke's testimony. (*See* Doc. 40).
- 3. To ensure clarity and conformance with the requirements of 20 CSR 4240-2.130, the OPC now seeks leave to file a corrected copy of the highly confidential version of Dr. Marke's Rebuttal Testimony, which is attached to this Motion as Attachment A. This document corrects the three inadvertent and non-substantive errors in the originally-filed document in that it: (1) includes page numbers, (2) includes the

heading on the first page and each subsequent page, and (3) deletes a stray 35 on the Table of Contents.

4. The substance of Dr. Marke's Rebuttal Testimony does not change.

WHEREFORE, the OPC respectfully requests that the Commission grant it leave to file the corrected copy of the highly confidential version of Dr. Geoff Marke's Rebuttal Testimony attached as Attachment A.
