JOINT STATUS REPORT ON STATEWIDE MEEIA FEASIBILITY STUDY

COME NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), the Office of Public Counsel ("OPC"), Renew Missouri Advocates d/b/a Renew Missouri ("Renew Missouri"), and Consumers Council of Missouri ("Consumers Council"), collectively, the "Parties," and jointly file a Joint Status Report ("Report") on the progress to implement the statewide Missouri Energy Efficiency Investment Act ("MEEIA") Feasibility Study.

1. On October 30, 2024, Ameren Missouri, OPC, Renew Missouri and Consumers Council submitted a *Stipulation and Agreement* ("Agreement") to the Commission for approval. The Commission issued its *Order Approving Non-Unanimous Stipulation and Agreement and Granting Waivers* on November 14, 2024. That *Agreement* included the submission of a revised *Ameren Missouri 2025-27 MEEIA Energy Efficiency Plan*.

2. Under the *Agreement*, the Parties agreed to conduct a Feasibility Study and open a non-contested workshop docket with certain considerations. The Parties also agreed to present progress at Public Service Commission ("Commission") Agenda meetings during the fourth quarter of 2024 and 2025. In lieu of making a fourth quarter presentation for 2024, the Parties filed status reports on January 15, 2025, and August 15, 2025. The Parties stated that they would file another status report regarding the progress made since the last status report. The Parties now provide the following status update.

3. Since the Parties' last update, the draft study by Opinion Dynamics and its subcontractor, American Council for an Energy-Efficient Economy, is on track to be completed by December 31, 2025, and the Parties anticipate the final draft will be completed by January 31, 2026.

WHEREFORE, the Parties respectfully request the Commission take notice of this third Status Report on the statewide MEEIA Feasibility Study.
