On December 15, 2025, the Staff of the Commission (Staff) filed its recommendation with attached memorandum regarding Spire Missouri Inc. d/b/a Spire's 2023-2024 Actual Cost Adjustment (ACA) filing. Staff listed certain comments, concerns, and recommendations set forth in the Billed Revenue, Actual Gas Cost, Reliability Analysis and Gas Supply Planning, and Hedging sections – and summarized in the Recommendations section – of the memorandum.
