On September 4, 2025, the Commission issued its *Order Setting Procedural Schedule, a Local Public Hearing, and Assignment of Exhibit Numbers*. The order set a Discovery Conference for December 18, 2025. The order also requires that any party with a discovery concern file a brief statement describing that concern at least three business days before each discovery conference. If no party identifies any discovery concerns the presiding officer may cancel that conference. No party has identified any discovery concerns. Therefore, the Regulatory Law Judge is canceling the discovery conference.

1. The December 18, 2025, discovery conference is canceled.
