STAFF RECOMMENDATION TO APPROVE TARIFFS

COMES NOW, the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and files its *Staff Recommendation to Approve Tariff Sheets*, and states the following in support:

- 1. On November 24, 2025, the Commission issued an *Order Regarding Ameren Missouri's Request for Approval of a Large Load Rate Plan and Associated Variance* ("Order") in which the Commission authorized Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") to file tariff sheets in compliance with the Order, the Stipulation and Agreement, and the exemplar tariff.
- 2. On December 5, 2025, Ameren Missouri filed thirty-six (36) tariff sheets, along with its accompanying tariff filing letter, ¹ to comply with the Order. The tariff sheets were assigned Tariff Tracking No. JE-2026-0076 with an effective date of January 4, 2026.
- 3. On December 8, 2025, the Commission issued an *Order Directing Staff Compliance Recommendation* ("Compliance Order"), ordering Staff to file its recommendation regarding the compliance tariff sheets no later than December 18, 2025,

and furthering ordering that any other comments about Ameren Missouri's compliance tariff sheets be filed no later than December 18, 2025.

- 4. Staff has reviewed the tariff sheets filed in Tariff Tracking No. JE-2026-0076 on December 5, 2025. Staff recommends the Commission approve the tariff sheets as filed on December 5, 2025, with effective dates of January 4, 2026.
- 5. This pleading is verified by the affidavit of a member of Staff, which is attached hereto and incorporated by reference herein.

WHEREFORE, for the reasons stated above, Staff recommends the Commission issue an order approving the following tariff sheets filed in this matter, Tariff Tracking No. JE-2026-0076, on December 5, 2025, with an effective date of no later than January 4, 2026:
