**NOTICE REGARDING SETTLEMENT CONFERENCE DATE**

COMES NOW Union Electric Company, d/b/a Ameren Missouri (“Ameren Missouri”), and on behalf of all of the parties, states as follows:

1. The Procedural Schedule in this case contemplates a Settlement Conference tomorrow, December 19, 2025, as had been specified by the parties when the parties filed their joint procedural schedule recommendation.

2. The undersigned counsel for the Company conferred with counsel for all parties respecting agreeing on a different date later in January 2026 for the conference, advising them that while the Company desires to have meaningful settlement discussions in this case, it is premature to have them at this time. Among other reasons, the Company is not yet in a position to meaningfully discuss possible settlement terms at this juncture of the case, including because it has had only a short time to consider the other parties’ rebuttal testimony (less than one week and just four business days<sup>1</sup>) and to examine the other parties’ workpapers (just one day). Counsel for the other parties indicated that they have no objection to postponing the conference.

3. The parties will soon confer on an alternative conference date in January and will advise the Commission of that date.
