NOTICE OF INTENDED CASE FILING

COMES NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro” or “EMM”) and pursuant to 20 CSR 4240-4.017(1), gives notice that it intends to file an application for certificates of public convenience and necessity (“CCN”), pursuant to Section 393.170 RSMo. and 20 CSR 4240-20.045, and state as follows:

1. 20 CSR 4240-20.045 contains the requirements for filing for CCNs for electrical production facilities.
2. The issues likely to be before the Missouri Public Service Commission in this case may be any issue related whether the requested natural gas generation is necessary or convenient to the public service.
3. Regarding the requirement in Rule 4.017(1) that a 60-day notice of filing include “a summary of all communications regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to the filing of the notice”, the EMM verifies that it has had no communications with the Office of the Commission (as defined in 20 CSR 4240-4.015(10)) respecting this filing during the 90 days prior to filing this notice.

4. EMM may seek a waiver of this Notice requirement when it files its CCN application.
